ADMISSIONS POLICY

EQUAL TREATMENT

All applications are considered equally, irrespective of the applicant's gender; marital or civil partnership status; pregnancy and maternity; any gender reassignment; race; disability; sexual orientation; religion or belief (including lack of religion or belief).

Minimum academic requirements are set for all courses to ensure that applicants have a realistic chance of completing their studies.

Minimum English language requirements are set for international students to ensure that they are able to cope with the linguistic demands of the course.

Our minimum age of entry is 14.

DISABILITY

The College has wheelchair access and we have the necessary lifts. Students are asked to contact the College with full details of the disability so we can assess whether we are able to provide the necessary support.

DISCLOSURES

Parents must disclose any known circumstances relating to their child's health, development, allergies, disabilities and learning difficulties. The College ensures that it can fully meet the needs of the student before a place is offered.

ADMISSIONS PROCEDURE

During the application stage the student must submit their latest school report, exam certificates (if applicable), copy of their passport, a completed and signed Application form. The student is invited to attend an interview with a senior member of staff.

Following a successful interview, the student will be offered a place at the College. To accept the place the student must return the acceptance and confirmation form together with the Registration Fee (£250) and Deposit (£2,000). References will be sought from the student's previous school.

SCHOLARSHIPS AND BURSARIES

Scholarships and bursaries are awarded at the discretion of the Principal. The aim of scholarships is to attract candidates of high academic potential into the College. Students applying for a scholarship sit our Scholarship Test and are interviewed by the Principal and the Vice Principal.

ENTRY POINTS

The usual entry points depending on ability and language level are:

September

Age 15: one-year GCSE programme.

Age 16 plus: Two year A level Programme or BTEC, Level 3.

Age 17 plus: Two year A level Programme, A Level year 2, International Foundation Programme or BTEC Level 3.

Age 18 plus: Two year A level Programme, A Level year 2, International Foundation Programme, BTEC Level 3 or one year A level programme/retakes.

January

Age 16 plus: 18 month A level programme/6 month pre-A level programme.

ENTRY REQUIREMENTS

GCSE - students should have positive school reports from their previous schools.

A levels - students should have a minimum of six GCSE passes at C grade or above, including English and Mathematics.

BTEC - students should have a minimum of six GCSE passes at C grade or above, including English and Mathematics.

International Foundation Programme - students should have equivalent to or higher than GCSE in at least 5 subjects and a minimum level of English equivalent to IELTS 5.0
